- f. Electronic bids must be submitted to the Water Supply, Irrigation and Energy Development office Dunai Dolpa through PPMO website www.bolpatra.gov.np/egpon or before 12:00 PM on 2081-08-11 (26th November, 2024). Bids received after this deadline will be rejected.
- g. Bids shall be opened in presence of bidder's representatives who choose to attend on 2:00 PM on 2081-08-11 (26th November, 2024) at the office of Water Supply, Irrigation and Energy Development office Dunai Dolpa. Bids must be valid for a period of 90 days counting.
- h. From the day of bid opening and must be accompanied by bid security (as mentioned above) which shall be valid for minimum 30 days beyond the bid validity period.
- i. If the last date of submission and opening falls on a government holiday, then the next working day shall be considered the last date. In such a case, the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
- j. The Employer reserves the right to accept or reject, wholly or partly, any or all the bids without assigning reason, whatsoever.
- k. The Condition, Process and Procedures not mentioned above will be as per GoN public procurement act-2063 and public procurement Regulation-2064.
