- g. Bids shall be opened in presence of bidder's representatives who choose to attend on 2:00 PM on 2081-09-03 (18th December, 2024) at the office of Water Supply, Irrigation and Energy Development office Dunai Dolpa. Bids must be valid for a period of 90 days counting.
- h. From the day of bid opening and must be accompanied by bid security (as mentioned above) which shall be valid for minimum 30 days beyond the bid validity period. Its Means 120 Days from above mentioned date of Opening.
- i. If the last date of submission and opening falls on a government holiday, then the next working day shall be considered the last date. In such a case, the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
