Invitation for Electronic Bids

1. **Water Supply, Irrigation and Energy Development Office, Dunai Dolpa** has allocated funds from **Karnali Province Government** towards the cost of “Construction works for Gumbatara Samuhik Khanepani tatha Sinchai Ayojana Kaike Ga.pa-3-Dolpa, Khubukhola Dekhi Tupatara Syau Faram Samma Sinchai Nirman, Kaike Ga.Pa.-4 Dolpa, Tongna Sinchai Yojana Nirman Kaike 3 Dolpa, Finga Samudayak Krishi Kheti Sinchai Kaike 1 Dolpa, Silung Dekhi Rungpuni Samma Sinchai Yojana Kaike Ga.Pa.-2, Dolpa, Elakot Chadama Tatbandhan Ayojana Kaike Ga.Pa. 3 Dolpa, Chhowa Khursani Sinchai Nirman Kaike Ga.Pa.-5 Dolpa and Era Sinchai Nirman Yojana, Kaike Ga.Pa.-06, Dolpa” and intends to apply part of the funds to cover eligible payments under the Contract **01-WIEDO/DOLPA/WORK/NCB/2082-083**. Bidding is open to all eligible as per Section V of bidding document.
2. **Water Supply, Irrigation and Energy Development Office, Dunai Dolpa** invites electronic bids from eligible bidders for the construction of “Construction works for Gumbatara Samuhik Khanepani tatha Sinchai Ayojana Kaike Ga.pa-3-Dolpa, Khubukhola Dekhi Tupatara Syau Faram Samma Sinchai Nirman, Kaike Ga.Pa.-4 Dolpa, Tongna Sinchai Yojana Nirman Kaike 3 Dolpa, Finga Samudayak Krishi Kheti Sinchai Kaike 1 Dolpa, Silung Dekhi Rungpuni Samma Sinchai Yojana Kaike Ga.Pa.-2, Dolpa, Elakot Chadama Tatbandhan Ayojana Kaike Ga.Pa. 3 Dolpa, Chhowa Khursani Sinchai Nirman Kaike Ga.Pa.-5 Dolpa and Era Sinchai Nirman Yojana, Kaike Ga.Pa.-06, Dolpa” under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
3. Only eligible bidders with the following key qualifications should participate in this bidding:
4. Minimum Average Annual Construction Turnover of the **best 3 years** within the last 10 years: **NRs . 35.945 Million**
5. Minimum Work experience of similar size and nature: **Minimum One Irrigation related works of NRs. 9.46 Million.**
6. Bidder who chooses to submit their bid electronically, Bidders are required to submit two separate bid response documents, one containing (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 21 of the Bidding Document.

Or Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the account as specified below .

9. Pre-bid meeting shall be held at **Water Supply, Irrigation and Energy Development Office, Dunai Dolpa** at **2082-06-20(06 October, 2025)**
10. Electronic bids must be submitted to the office **Water Supply, Irrigation and Energy Development Office, Dunai Dolpa** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 Noon** on **2082-06-31 (17 October, 2025)** Bids received after this deadline will be rejected.
11. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00PM of 2082-06-31 (17 October, 2025)** at the office of **Water Supply, Irrigation and Energy Development Office, Dunai Dolpa**. Bids must be valid for a period of **90** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **7,00,000**, which shall be valid for 30 days beyond the validity period of the bid.
12. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
